ALL WATER METERS, VALVES, FIRE HYDRANTS AND WATER MAINS ARE LOCATED ON LOS ANGELES COUNTY RIGHTS-OF-WAY AND EASEMENTS. THEY ARE NOT LOCATED ON OUR CUSTOMERS' PROPERTY.

IN CASE OF AN EMERGENCY, ACCESS TO WATER METERS, VALVES, FIRE HYDRANTS AND WATER MAINS LOCATED ON LOS ANGELES COUNTY RIGHTS-OF-WAY AND EASEMENTS MUST BE ACCESSIBLE BY WATER COMPANY PERSONNEL TWENTY-FOUR (24) HOURS A DAY, SEVEN (7) DAYS A WEEK.

THE WALNUT PARK MUTUAL WATER COMPANY IS NOT RESPONSIBLE FOR ANY DAMAGE TO GATES, FENCES, WALLS OR ANY OTHER OBSTICLES PREVENTING ACCESS TO COMPANY WATER METERS, VALVES, FIRE HYDRANTS AND WATER MAINS LOCATED ON LOS ANGELES COUNTY RIGHTS-OF-WAY AND EASEMENTS.

ANY FENCES, WALLS OR ANY OTHER OBSTICLES CONSTRUCTED ON LOS ANGELES COUNTY RIGHTS-OF-WAY OR EASEMENTS ARE CONSIDERED AN ENCROACHMENT BY THE LOS ANGELES COUNTY DEPARTMENT OF PUBLIC WORKS AND ARE SUBJECT TO REMOVAL AT ANY TIME.
